4.2 Documents submitted on time by bidders shall not be returned.

5 LATE BIDS

5.1 Bids received late shall not be considered. A bid will be considered late if it arrived even one second after 11:00 or any time thereafter. The tender (bid) box shall be closed at exactly 11:00 and bids arriving late will not be considered under any circumstances. Bids received late shall be returned unopened to the bidder. Bidders are therefore strongly advised to ensure that bids be despatched allowing enough time for any unforeseen events that may delay the delivery of the bid.

5.2 The official Telkom time, which can be observed by dialling 1026 from any phone, will be used to verify the exact closing time.

5.3 Bids sent to the NEMISA via normal post or any other mechanism shall be deemed to be received at the date and time of arrival at the NEMISA premises (tender/bid box or reception). Bids received at the physical address after the closing date and time of the bid, shall therefore be deemed to be received late.

6 PAYMENTS

6.1 NEMISA will pay the Contractor the fees set out in the final contract according to the table of deliverables. No additional amounts will be payable by the NEMISA to the Contractor.

6.1.1 The Contractor shall from time to time during the duration of the contract, invoice NEMISA for the services rendered.

6.1.2 The invoice must be accompanied by supporting source document(s) containing detailed information, as NEMISA may reasonably require, for the purposes of establishing the specific nature, extent and quality of the services which were undertaken by the Contractor.

TERMS OF REFERENCE (TOR)

The appointment of Sound Proofing

BACKGROUND

The National Electronic Media Institute of South Africa was established as a non-profit institute for education in terms of the Companies Act (No 61 of 1973) and is listed as a schedule 3A public entity in terms of the Public Finance Management Act (No 1 of 1999).

NEMISA derives its mandate from the Department of Communications and Digital Technologies (DCDT). The institute delivers Creative Media and Digital skills training for South African citizens with particular focus on the youth, women, people with disabilities and SMME's. NEMISA has prioritised rural and developing areas in its skills development initiatives.

TERMS OF REFERENCE

Background

NEMISA require the services of a qualified service provider to assist with the methodology and reconfigurations of the institutes 2 radio studios, and sound booth fire sprinklers, fire detection, electrical system, air condition redesign. These mechanical or technical systems are currently installed in the site where the radio studios are built, and NEMISA want to install sound proofing of the studios. For these studios to restrict sound from protruding during the production and live presentations.

SPECIFICATIONS

The service provider will be required to amongst other things:

- To come plan on how this sprinklers system, fire detection, electrical system, centralised system, and the cables on roof should be treated during the sound proofing projects
- Develop the methodology to approached and implement the project.
- The floor plan and the installation thereof of these technical systems
- Proposal and installation of the FM 200 or suppression system
- Installation of the ceiling panels.
- Implement the proposal about sprinklers system, fire detection, electrical system, centralised system.

1.2.2 The score for functionality shall be calculated as follows:

- Each panel member shall award values for each individual criterion on a score sheet. The value scored for each criterion shall be multiplied with the specified weighting for the relevant criterion to obtain the marks scored for the various criteria. These marks should be added to obtain the total score for functionality.
- The score of each panel member shall be added together and divided by the number of panel members to establish the average score obtained by each individual bidder for functionality.

1.3 ELIMINATION OF PROPOSALS ON GROUNDS OF FUNCTIONALITY

- 1.3.1 Bids that score less than **80%** of the marks available for functionality will be eliminated from further consideration. Marks will therefore not be awarded for their cost proposals or for preference.

1.4 PRICE AND B-BBEE STATUS LEVEL POINTS

- 1.4.1 All remaining bids will be evaluated as follows:
- 1.4.2 The 80/20 preference point system will be applied. Points for price and B-BBEE status level certificate will be awarded in accordance with the stipulations in the Preference Point Claim Form in terms of the Preferential Procurement Regulations, 2017.
- 1.4.3 If appropriate, implied contract price adjustments will be made to the cost proposals of all remaining bids.
- 1.4.4 The point scored for the B-BBEE status level certificate for each acceptable bid will now be added to the price point.
- 1.4.5 The Evaluation Committee may recommend that the contract be awarded to the bidder obtaining the highest aggregate mark as determined by 1.4.4 or to a lower scoring bid on justifiable grounds.

1.5 ADJUDICATION OF BID

- 1.5.1 The relevant award structure will consider the recommendations and make the final award. The successful bidder will usually be the service provider scoring the highest number of points or it may be a lower scoring bid on justifiable grounds or no award at all.
