REQUEST FOR QUOTATIONS FOR BOARD AND COMMITTEE EVALUATION

1. BACKGROUND

NEMISA is a national public entity listed as a Schedule 3A under the PFMA and registered as a non-profit Company under the Companies Act 71 of 2008 and reports to the Minister of the Department of Communications and Digital Technologies (DCDT).

In line with the Governance Agreement entered into between the DCDT Minister, NEMISA Board and Committees Evaluation Framework and Principle 9 of the King IV Report indicates the Board must ensure that the evaluation of its performance, its Committees, Chairpersons' and individual Members is conducted annually.

2. PURPOSE

Over and above evaluating the overall performance of the Board as per the Performance Balanced Scorecard in the Governance Agreement, NEMISA requires the services of an external service provider to determine the following, as per the NEMISA Board and Committees Evaluation Framework:

2.1 The Board:

- 2.1.1 Whether the Board is successfully fulfilling its oversight mandate; and
- 2.1.2 To identify areas of enhancement in improving the efficiency and functionality of the Board.

2.2 Board Committees:

- 2.2.1 Whether the Committees are successfully fulfilling their oversight mandate as per the Committee Charters;
- 2.2.2 Whether the Committees are effectively supporting the Board with aspects or areas delegated to them;
- 2.2.3 To identify areas of enhancement in improving the efficiency and functionality of the Committees; and
- 2.2.4 To identify areas of development while providing lessons learned for the future.

2.3 Board and Committee Chairpersons:

- 2.3.1 If the Board and Committee Chairpersons are successfully guiding the Board and Committees to perform their core functions and achieve their respective mandates as outlined in their respective Charters.

The current Board comprises six (6) Board members, one (1) executive Director being the Chief Executive Officer and an Independent Audit and Risk Committee Chairperson.

- Reports containing the results of the Council Committee self-evaluations (“Board Committee Evaluation Reports”). These reports are compiled on the same premise and approach as above. The reports will be shared with the Board Chairperson and Company Secretary unless otherwise notified in writing by the Board Chairperson or Company Secretary.
- Reports containing the results of the Peer Evaluations (“Peer Evaluation Reports”). These reports are compiled on the same premise and approach as above. The reports will be shared with the Board Chairperson and Company Secretary unless otherwise notified in writing by the Board Chairperson or Company Secretary.

- The reports should include an Action Plan for the ensuing financial year based on the outcomes.
- The facilitator will be required to present a high-level overview of the results to the Committees and Board (30 minutes - 1 hour for Committees and 1 - 2 hours for Board).

The Reports must be provided in PDF format to ensure version control and integrity.

1.2 COMPLIANCE WITH MINIMUM SPECIFICATION REQUIREMENTS

All remaining bids will be assessed in terms of compliance with the minimum specification requirements.

Bids which do not comply with the minimum specification requirements will be eliminated from further consideration.

1.3 PRICE AND SCM EVALUATION CRITERIA

1.3.1 All remaining bids will be evaluated as follows:

1.3.2 The 80/20 preference point system will be applied. Points for price and SCM evaluation criteria will be awarded .

1.3.3 If appropriate, implied contract price adjustments will be made to the cost proposals of all remaining bids.

1.3.4 The Evaluation Committee may recommend that the contract be awarded to the bidder obtaining the highest aggregate mark as determined by 1.3.4 or to a lower scoring bid on justifiable grounds.

1.4 ADJUDICATION OF BID

1.4.1 The relevant award structure will consider the recommendations and make the final award. The successful bidder will usually be the service provider scoring the highest number of points or it may be a lower scoring bid on justifiable grounds or no award at all.


